STRIKE A POSE

Typically, when painting the ceremony, such as the facing vows pose, and forward facing exit scene, I will do my best to grab a photo for reference at the moment it is happening. If I'm unable to get that perfect shot, I may ask for a pose. This isn't always convenient, so we have another option! We will arrange a time to take the photo at your venue, before or after the ceremony.

If you choose to add-on additional guests to your painting, I may request to take photos of them to capture their likeness in the painting.

This may take 5-15 minutes to capture.

FIRST LOOK

If you are planning to do a first look prior to your ceremony, then I would love the opportunity to get a photo in your chosen pose before the ceremony begins. This provides me with more time to focus on the whole painting. If not, no problem! When the ceremony ends, we will plan a moment to capture your perfect pose.

SPECIAL REQUESTS

1. RETAINER

A retainer of 25% of the total cost of the order is used to secure Emmy's services, and to reserve your date. This is non-refundable. This 25% retainer includes the price for both the painting and any travel fees associated with the painting. If shipping is required, this cost is not included and will be addressed in a separate invoice, depending on package option. Sales tax will be applied to the retainer.

2. PAYMENT

Payment is divided into two payments, the 25% retainer which is required to reserve the date, and the final payment which is due no later than one week (7 days) before the wedding date. For your convenience, an invoice will be sent several weeks before the wedding date. Payment may be made via Venmo (@Emmy-hunter) check, cash, or credit card (no convenience fee). Failure to pay before the event will result in a delay of receiving your finished piece until full payment is made. Payments can be broken down into monthly installments, if client requests. Sales tax will be applied to all services.

3. EQUIPMENT

Easels, lights, (Extension cords are not needed) floor protection (if required), paints, canvas, brushes, rags, buckets, and all that pertains to executing a live painting are provided by the Artist as required. A chair may be requested during the reception. No additional table or special furniture is required, with the exception of extreme weather. In the event that temperatures are above 90° for outdoor weddings, the venue or wedding party shall provide a canopy, umbrella or shaded area for the artist. In some cases, the artist reserves the right to use a portable umbrella if needed. In the event that temperatures fall below 45° at an outdoor wedding, please provide an outdoor heater or an indoor space. If travel requires flying, additional cost may be included for supplies that need to be purchased locally.

4. ACCESS

The Wedding Party is responsible for making sure Emmy has access to the venue for preview, freedom to set up easel(s) in tasteful but obvious location(s), access to venue at least 2 hours ahead of scheduled events for set-up, access to communicate with Event Planners/Wedding Planners, Venue Representatives, Photographers ahead of event. Please note, Emmy will take photos of the couple before the ceremony, during the ceremony or reception, and sometimes additional photos from which to paint.

5. TRAVEL EXPENSES

Travel expenses are as follows: Locations that are within 30 miles of the artist's location will not incur travel expenses. Driving mileage: .80¢ per mile each way for events over 30 miles from the artist's location (a total of 60 miles are free to client). Cost for hotel stay, airline, and/or car rental will be determined by destination. Estimated mileage for your wedding from Artist's home in Richmond, Ky, 40475. Weddings that require a hotel stay will have a \$50-\$75 per diem charge.

6. LODGING EXPENSES

One, two or three nights lodging (usually just one night if the wedding is 4 or less hours of driving each way). Reasons for a one night stay and/or additional nights may include:

- (1) Night BEFORE the wedding to allow for travel, purchases, preview of venue, and any unforeseen circumstances
- (2) Night immediately after the wedding & reception
- (3) Night the day after the wedding so that Emmy can finish the painting locally, if necessary, and deliver it to the responsible party before traveling home.

7. COMPLETION

The painting(s) will be completed in Emmy's studio within 4 to 6 months from the wedding (or dinner if possible). However, time may vary. The wedding party will be responsible for shipping cost, if necessary. Finishing in the studio ensures that the final piece will meet the highest expectations for a finished heirloom painting. Painting will be completed in a realistic style, but will still have artistic interpretation. The people depicted in the painting will be based on photo references and will resemble their likeness. The reference photo will be approved by the couple prior to painting. This reference photo is strictly used for my work and will not be shared with the wedding party during the painting process.

8. UPGRADES & ADDITIONS

Upon signing this contract, client agrees to maintain the package selection for the painting. If the client would like to upgrade to a larger package option, please inform Emmy two weeks or more ahead of the event. In the event of an upgrade, a new contract will be created. Client cannot downgrade once retainer is secured and contract is signed.

- If client requests smaller package option after contract and retainer have been signed and paid, the balance of the original contract will remain. The difference in price can be supplemented with in-studio paintings.

Additions can be made before or after the event. Please inform Emmy of any additions as soon as possible. Some additions may not be available due to package option, composition, and reference photo availability.

9. REVISIONS & REWORKS

If client is unhappy with the outcome of the painting, then revisions can be made. A total of two (2) large revisions/reworks will be provided for a painting. If after two reworks the client is still dissatisfied with the finished piece, then additional revisions will be an additional expense. Every rework after the initial two revisions will cost \$225/per rework.

10. REFUNDS

If the Wedding Party cancels Emmy's services 8 weeks or more before the scheduled event, a full refund, excluding the 25% retainer, will be refunded to the Wedding Party. If services are canceled within 8 weeks or less, all payment made thus far will be forfeit by client. Forfeit payment, including your retainer, can go toward an in-studio commission piece of your choice. Sale of finished artwork is final.

- If the Artist, Emmy, falls ill, is injured, or cannot attend due to dangerous weather conditions, she will paint from a professional photo that you send after the wedding. 25% of the painting price shall be refunded to the Wedding Party and all travel expenses refunded.

11. PHOTOGRAPHY AND VIDEO

The Wedding Party is allowed to photograph or video the Artist and her artwork in any manner during the engagement. Likewise, Emmy may photograph any part of the wedding celebration in order to carry out the task of painting the event. In the future, Emmy may also photograph and video her own painting process for marketing and promotion. Emmy reserves the right to use photos of the finished painting for marketing and promotion. If any professional photos are taken of the artist or art, please share the photos with Emmy. These photos will be used to share your big day and for marketing material in the future!

12. FOOD & AMENITIES

If the wedding celebration covers a normal period of time (4-6 hours), then food and drink will be made available to Emmy. (to-go boxes are appreciated when available.) If food and drink is not available, the Artist must be notified in advance.

13. FINAL INVOICE

A final invoice will be sent to the Wedding Party a month before the date of the event. Payment is due no later than one week (7 days) before the wedding date.

14. SHIPPING

The painting can be picked up in studio, or you can take advantage of free delivery within 30 miles of Richmond, Ky. All other shipping cost will be sent in a separate invoice when painting is completed and ready for shipment. Shipping cost is only included in the Signature and Grand Package options.

15. EQUIPMENT DAMAGE & THEFT

Any damage or theft of the Artist's supplies or equipment caused by guests or venue at the event will be paid for by Client, payable before art is delivered.

16. SITUATIONS REQUIRING ARTIST TO VACATE PRIOR TO END TIME OF EVENT & FINISH IN-STUDIO

Situations include, but are not limited to, guest misconduct, electrical insufficiency, safety hazards, rain exposure (no cover available), and Artist injury. While such occurrences are very rare, Emmy's judgment determines if early venue exit is necessitated.

17. PAINTING DAMAGE BY GUEST

If the painting is damaged by guests, the artist will immediately notify the wedding party (Bride, Groom, or paying party) or wedding planner of the incident. The severity of the damage will determine the action taken. Small repairs will not require any additional cost, but may result in repair being completed in-studio. Large repairs (i.e. a break in the canvas or large scale paint smear) may result in a repair fee.

18. LIABILITY INSURANCE

Antler and Oak Art maintains liability insurance for all events. If the client's venue needs proof of certificate of Insurance (COI) or requests to be added as an "additional insured," client must inform Emmy at least a month prior to the event.
